Fund Objective

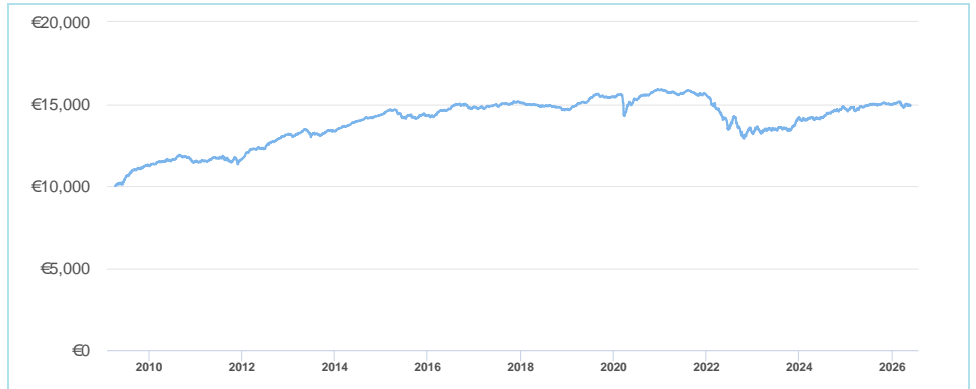
This fund is aiming to outperform the Market iBoxx Euro Corporate Bond Index over the long term.

Fund Strategy

- The fund invests principally in investment grade corporate bonds i.e. bonds issued by companies with high credit rating. The fund can also invest in bonds issued by government and cash.
- It is an actively managed fund with a target tracking error of 1% and a duration of +/- 2 years relative to the benchmark.
- The maximum exposure to non-Euro denominated bonds is 20% but all non-Eurozone currency exposure must be hedged.
- Derivatives may be used to reduce risk, such as foreign currency risk within the fund.
- This fund is classified as ESG Article 8 under EU SFDR.

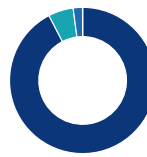
