#### Fund Objective

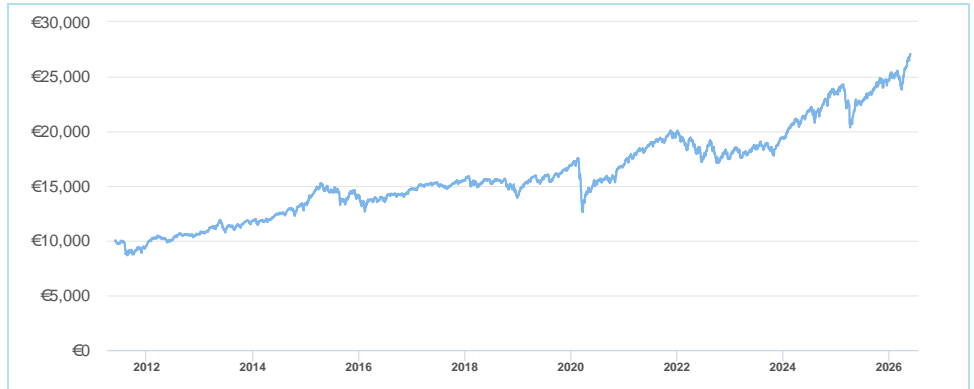
The fund's primary aim is to maximise returns within a specified volatility target of between 10% and 15% per annum over a rolling five-year period.

- The fund gives exposure to many different asset classes including but not limited to cash, bonds, equities, property and alternatives.
- The underlying strategies are both passive and active in nature. Some are managed internally by Aviva Investors, whilst others are managed externally.
- The asset mix of the Fund shall be rebalanced on a periodic basis taking into account the result of the Managers asset allocation

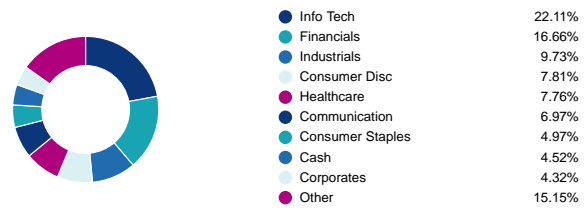
